In the long term, are there plans for the institution to return to an entirely in-person delivery once more, thereby ending the blended approach? If so, how?

The Vice-Chancellor reported that the University was planning to return to primarily in-person delivery for the academic year 2021/22, government advice permitting. However, the University would also reflect on those positive attributes of online delivery and how these could be incorporated into teaching in the longer-term.

5. REPORT OF THE VICE-CHANCELLOR

- 5.1 The Vice-Chancellor provided an oral report, including the following.
 - (i) Professor Leitch and Professor Rycroft-Malone had been elected as the Senate representatives on Council. He recorded his thanks for all who had participated.
 - (ii) Congratulations to all who had been elected as the Student Officers for 2021/22, as well as to Misbah Ashraf for her appointment as Chief Executive Officer of the Students' Union on a permanent basis.
 - (iii) The University had conducted an audit of its teaching provision looking at deliverables against published expectations. He reported that Senate could be reassured that the audit had evidenced that the University had met expectations.
 - (iv) The Government had reported that their intention was that all students would be able to return to face-to-face teaching from 17 May. The Vice-Chancellor reported on the associated planning within the University, noting that the campus had been and remained open throughout the pandemic, operating in line with restrictions.
 - (v) More generally, it was noted that the national vaccine roll-out appeared effective and it was anticipated that a further easing of restrictions would be forthcoming. The University would reflect on its own experience identifying how the return to more standard operating processes could retain the agility and flexibility demonstrated by staff throughout the national emergency.
 - (vi) The OfS had written to all universities asking that they review institutional approaches to managing sexual misconduct.
 - (vii) The University was on track to submit to the Race Equality Charter in April 2021.
